RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY, PHOTO RELEASE, AND PARENTAL CONSENT AGREEMENT

In consideration of being permitted to participate in any way with Hometown Bicycles L.L.C, Team Hometown Bicycles, Team Hometown Bicycles-sponsored bicycling, or their activities (Activities), I, for myself, my personal representatives, assigns, heirs, and next of kin: Acknowledge, agree, and represent that I understand the nature of Hometown Bicycles L.L.C. Activities and that I am qualified, in good health and proper physical condition to participate in such Activities. I further acknowledge that the Activities may be conducted over public roads and other facilities open to the public during the Activities and upon the hazards of which traveling are to be expected. I further agree and warrant that if at any time I believe the conditions to be unsafe, I will immediately discontinue further participation in the Activities. I fully understand that: (a) bicycling and other Hometown Bicycles L.L.C. Activities involve risks and dangers of serious injury, including permanent disability, paralysis and death (Risks); (b) these Risks and dangers may be caused by my own actions, or inactions, or the actions or inactions of others participating in the Activities, the condition in which the Activities takes place, or the negligence of the "Releasees" names below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at the time, and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the Activities. I hereby release discharge, and covenant not to sue Hometown Bicycles L.L.C. their respective administrators, directors, officers, employees, volunteers, any sponsors, advertisers, owners, manufacturers, and if applicable, owners of property on which the Activities take place (each considered one of the "Releasees" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise; and I further agree that if, despite this Waiver of Liability, Assumption of Risk, and Indemnity Agreement I, or anyone on my behalf, makes a claim against any of the "Releasees", I will indemnify, save, and hold harmless each of the "Releasees" from any litigation expenses, attorney fees, loss, liability, damage, or cost which may occur as a result of such claim.
